Apex Lift & Escalator Engineers Ltd has been measuring its carbon footprint with Planet Mark for 4 years.

The Planet Mark measurement methodology is fully aligned to Greenhouse Gas (GHG) Protocol and all data is checked against evidence provided by Apex Lift & Escalator Engineers Ltd.

Apex Lift & Escalator Engineers Ltd's highest emitting category was Scope 1 Mobile Fuels at 50.2% of their total market-based footprint followed by Scope 3 Category 7: Employee Commuting at 31.8% of their total market-based footprint. Mobile Fuels has seen the largest decrease in emissions, reducing by 60.4 tCO₂e since 2024.

All Scope 2 emissions are reported using the market-based methodology unless stated otherwise.

This report compares this year's (YE2025) emissions to baseline year's (YE2024) emissions.

Apex Lift & Escalator Engineers Ltd has expanded its boundary this year in the following categories: Fuel- and Energy-Related Activities, Waste, Business Travel, Employee Commuting and accordingly comparisons throughout this report are presented using data that has been normalised to exclude any emissions that were reported for the first time this year. For transparency, non-normalised data comparisons are also shown in the data tables.

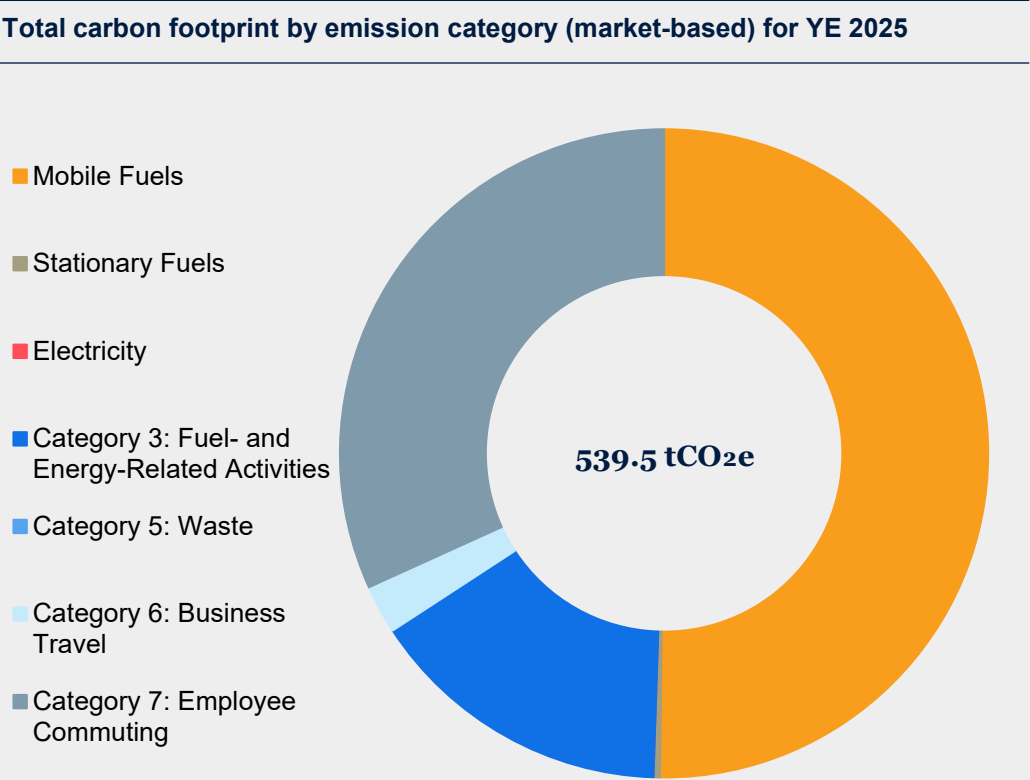

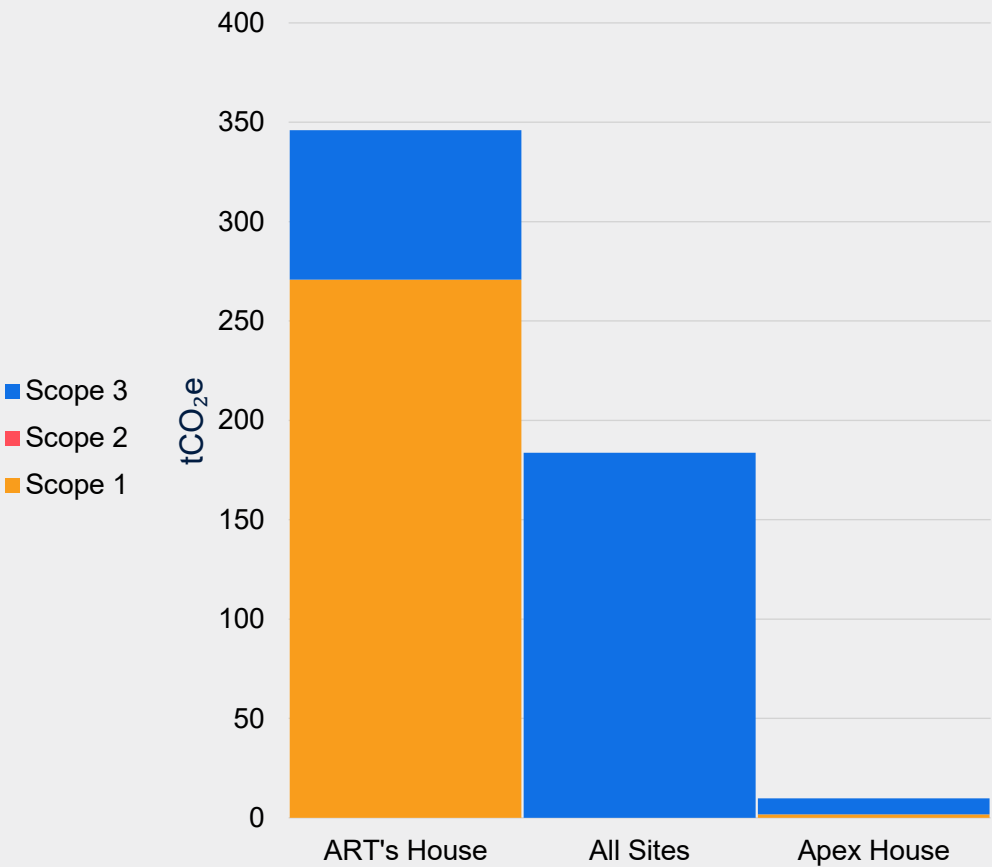

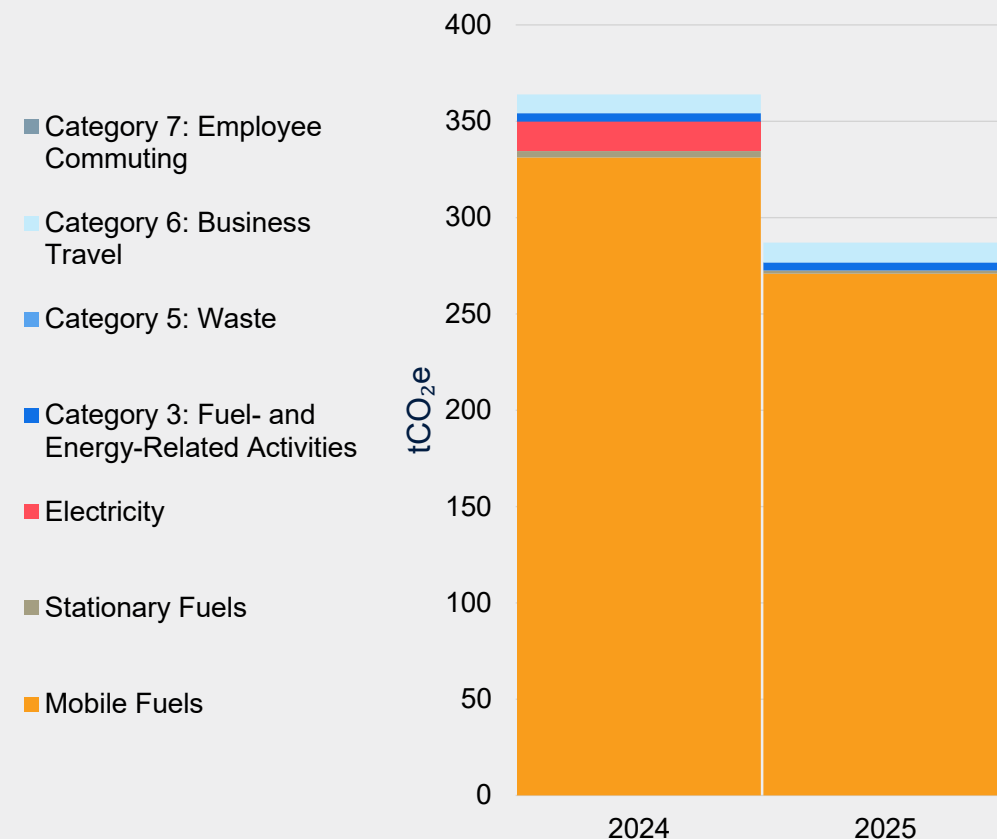
Carbon footprint by Scope 1, 2 & 3 (market-based) per location for YE 2025

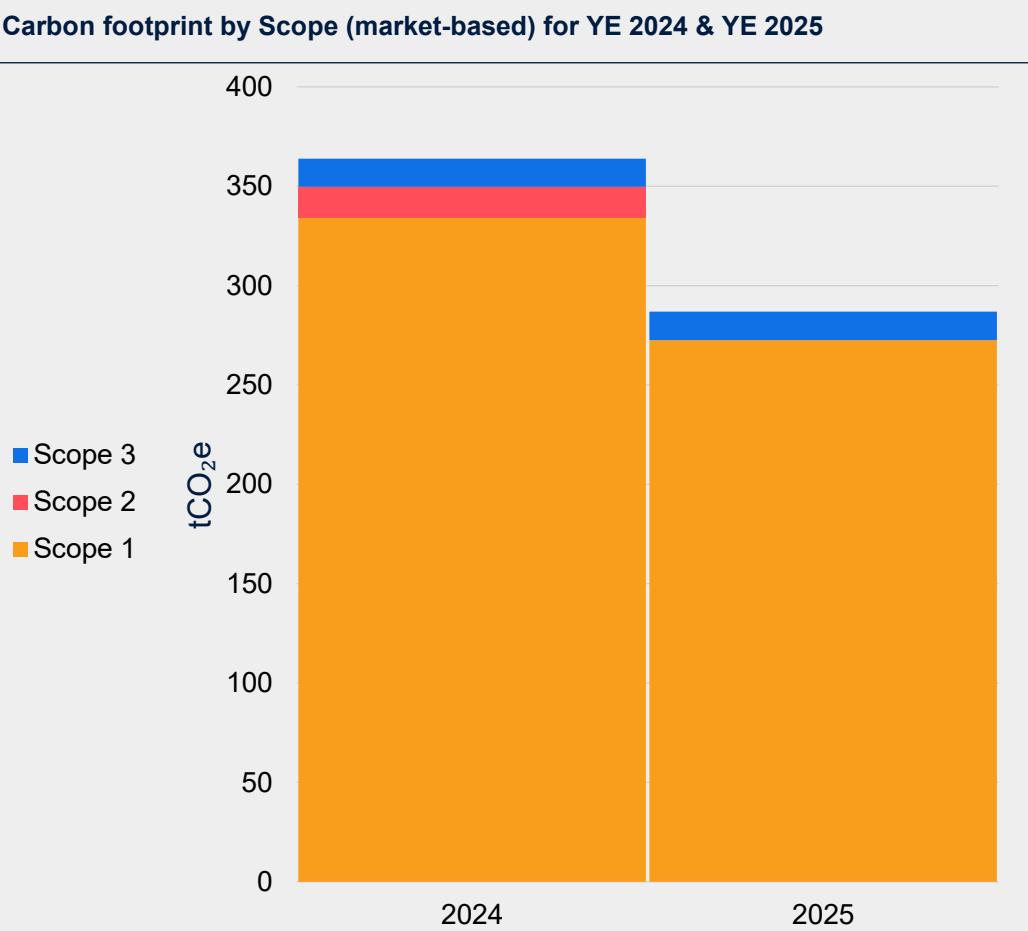
Total carbon footprint by emission category (market-based) for YE 2024 & YE 2025

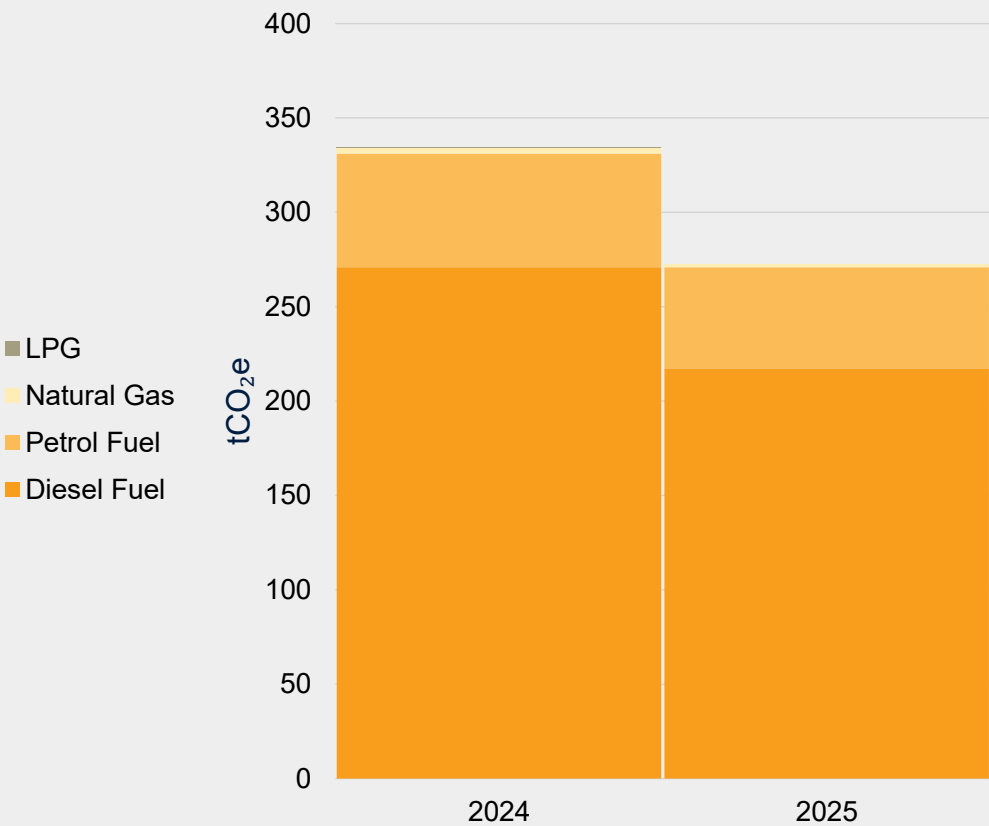

Scope 1 emissions contributed 50.52% of this year's total carbon footprint and decreased by 61.9 tCO₂e, primarily driven by lower diesel fuel emissions (-53.6 tCO₂e).

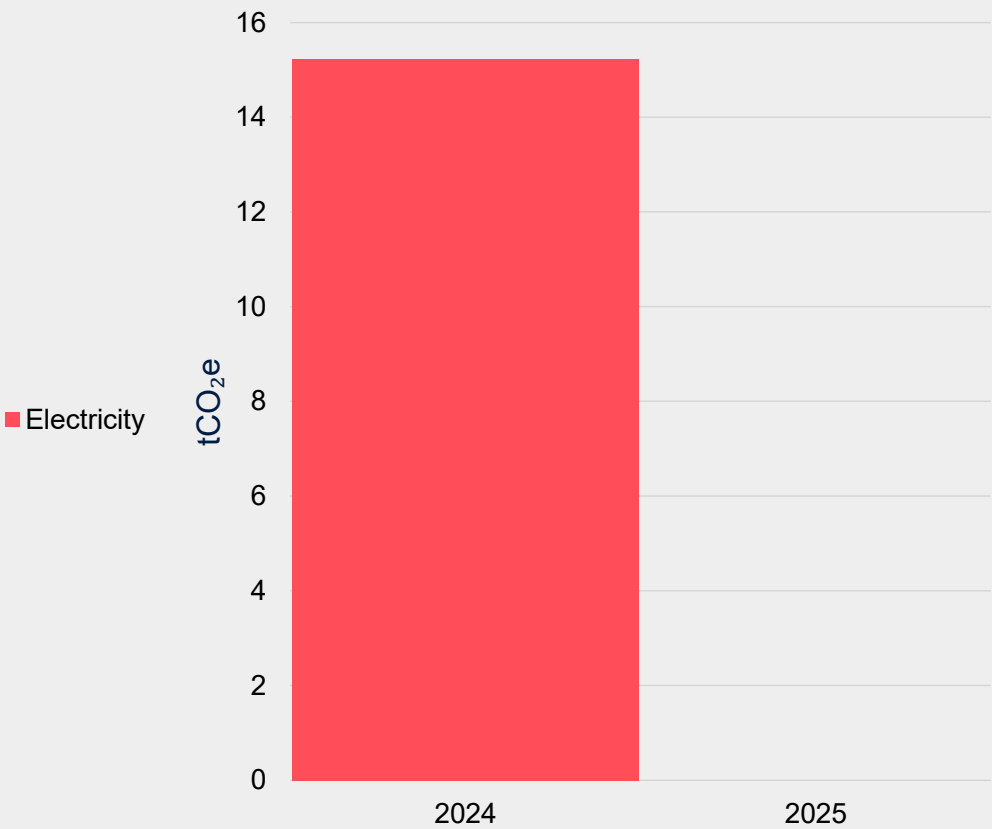

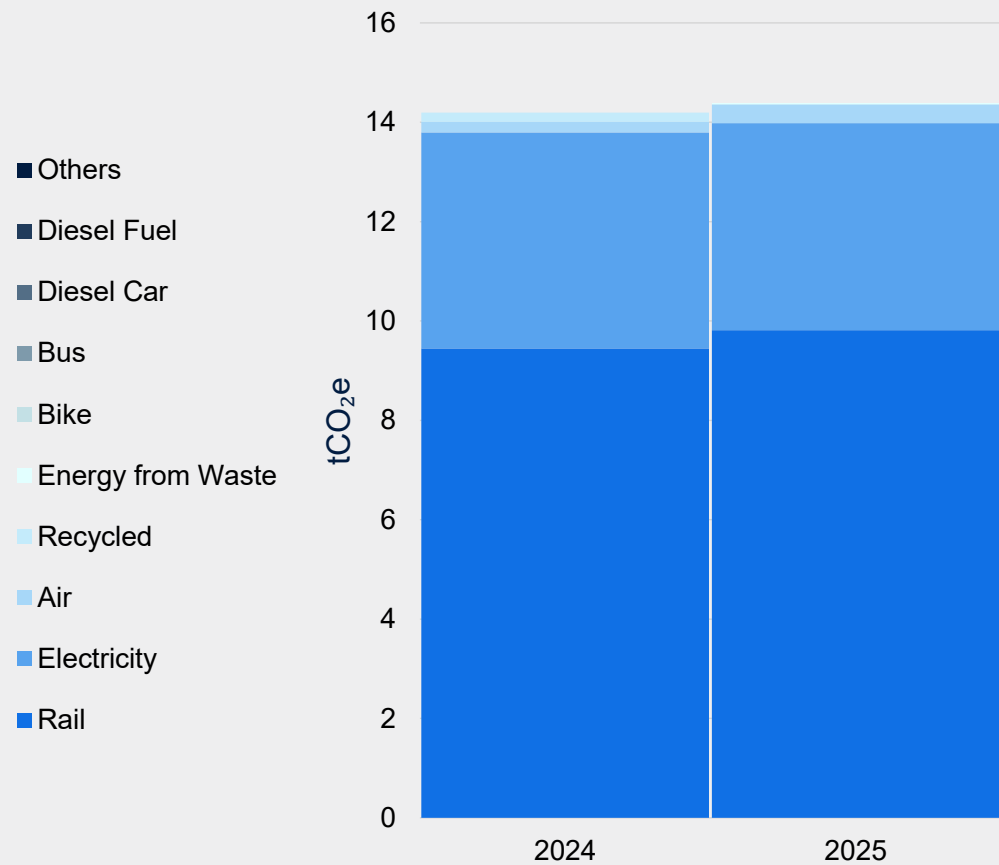

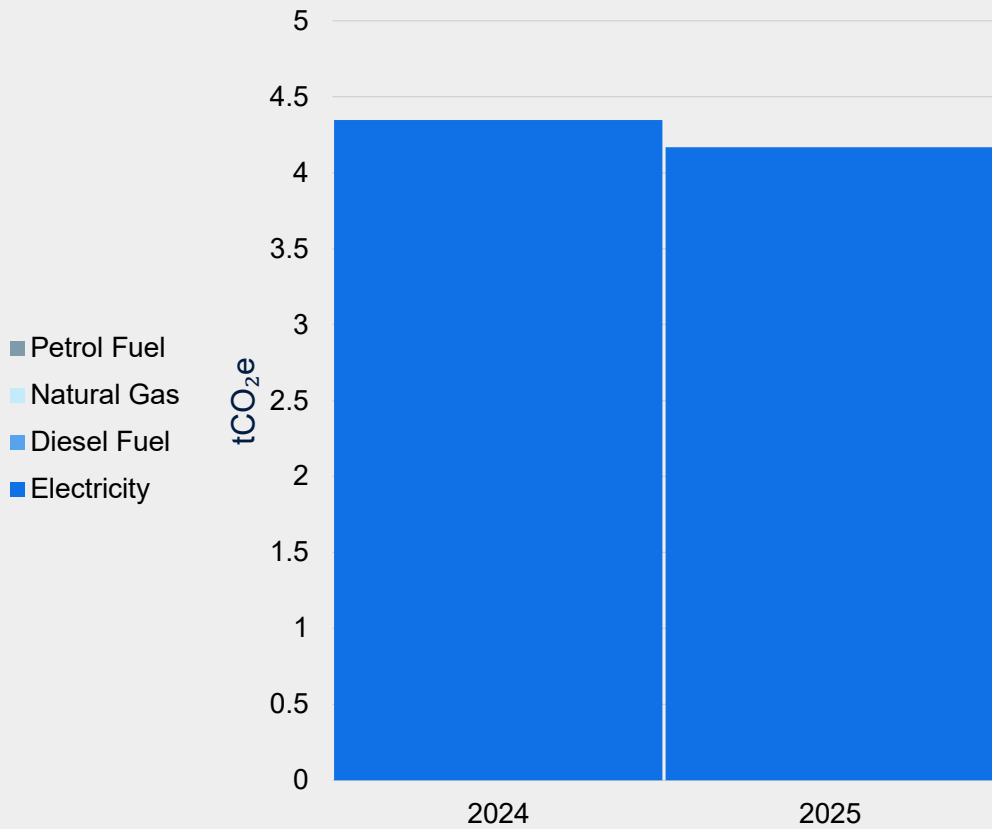

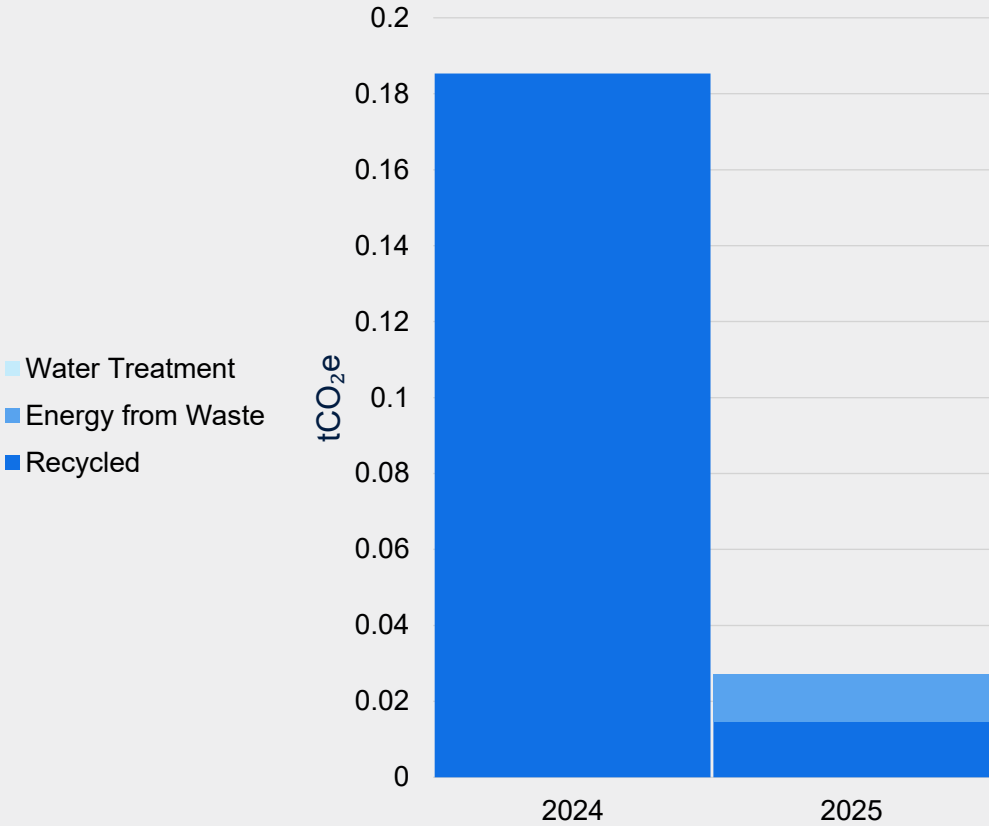

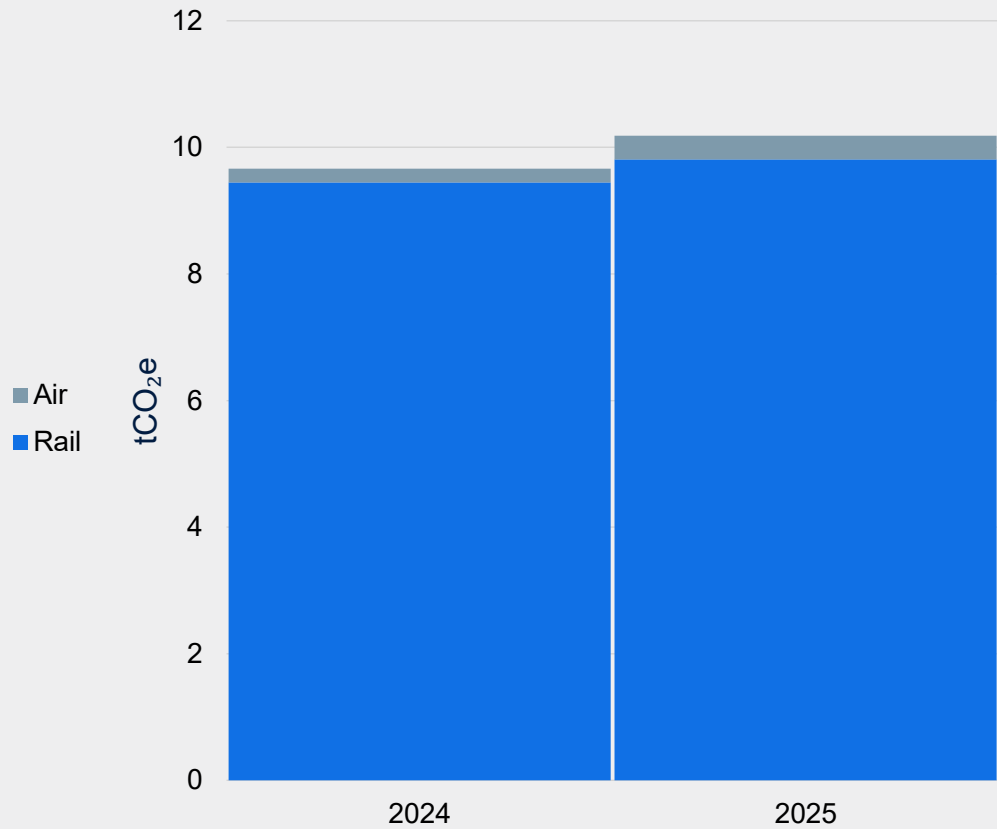

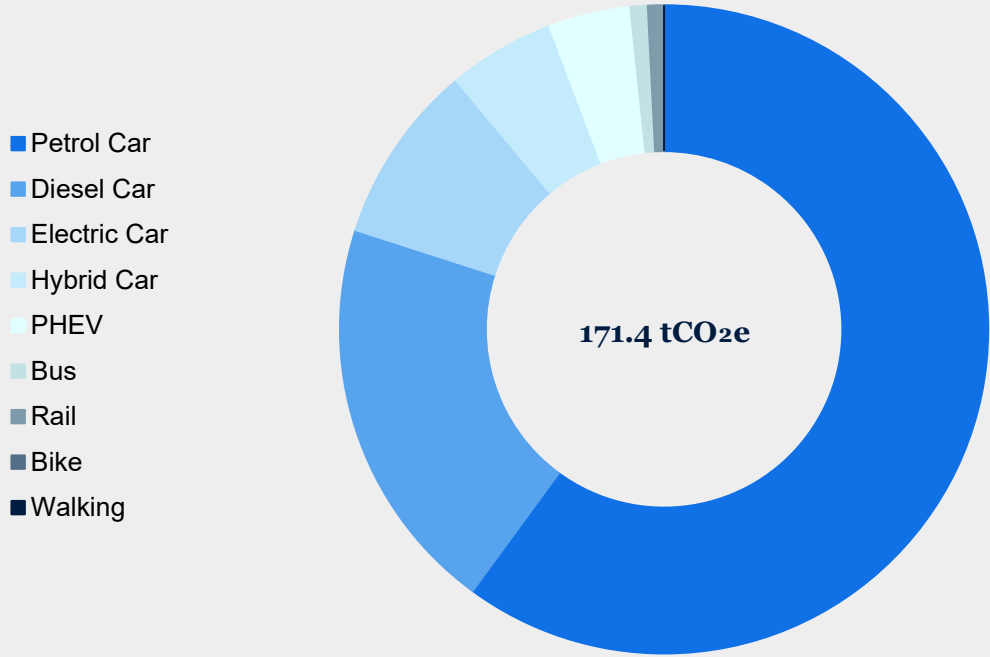

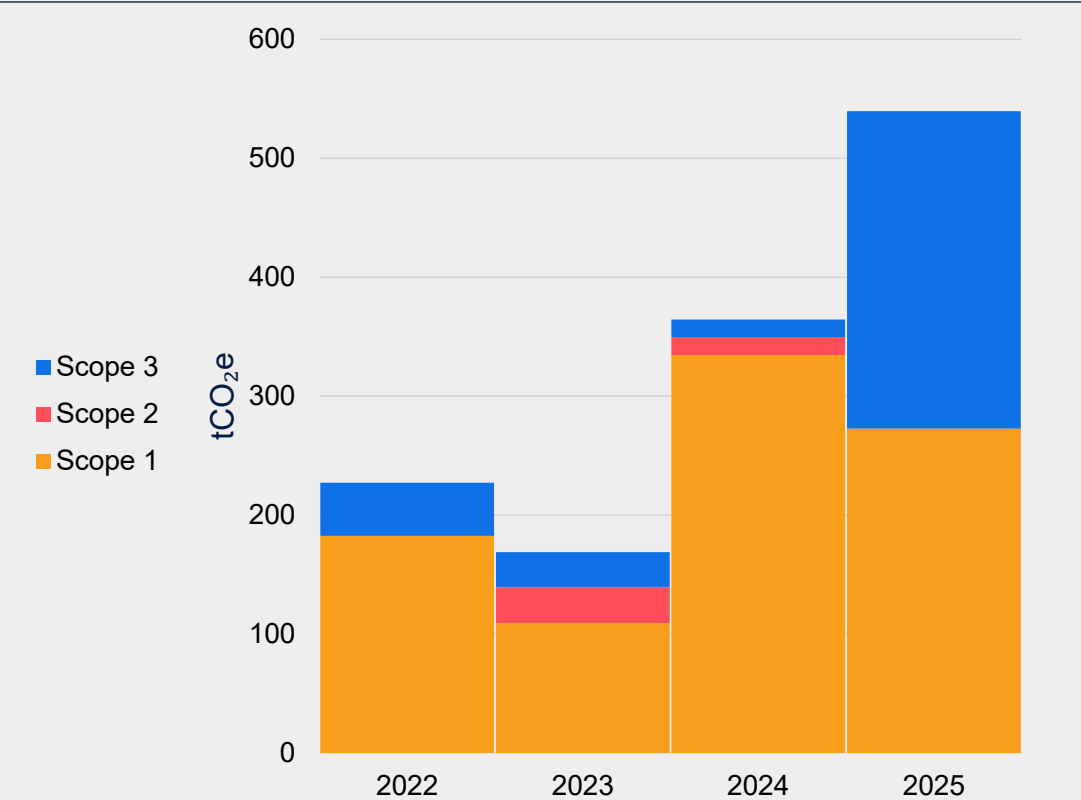

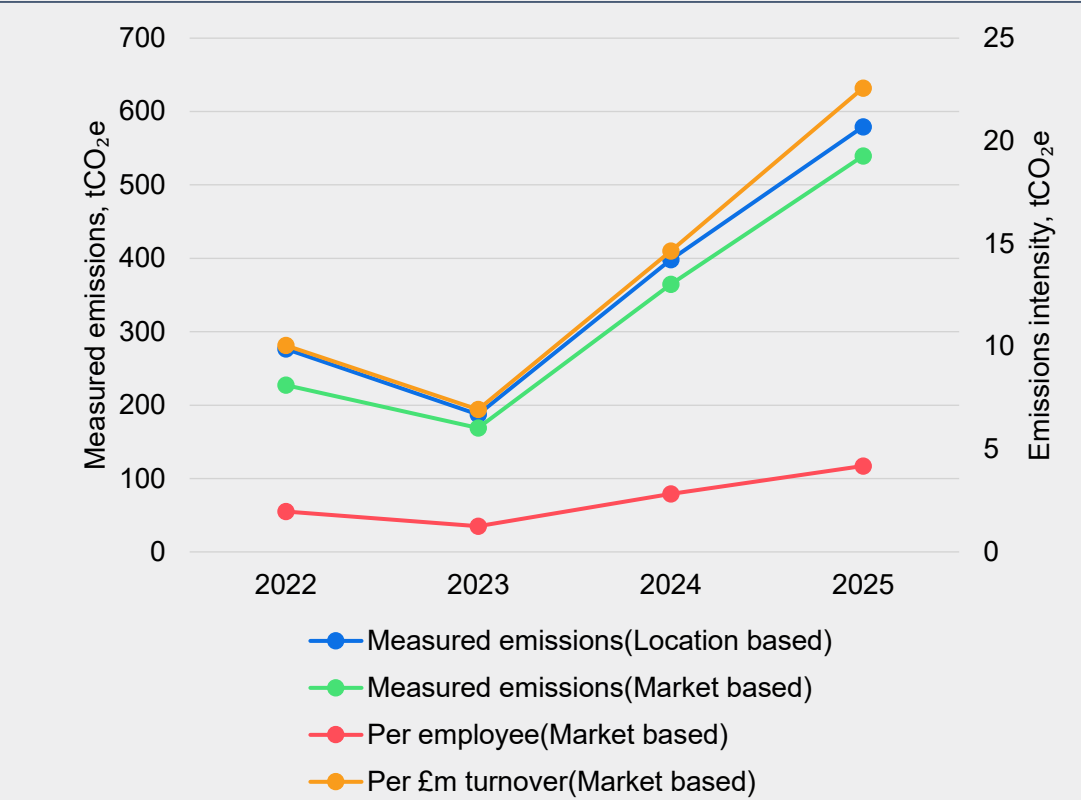
Measured carbon footprint throughout the years

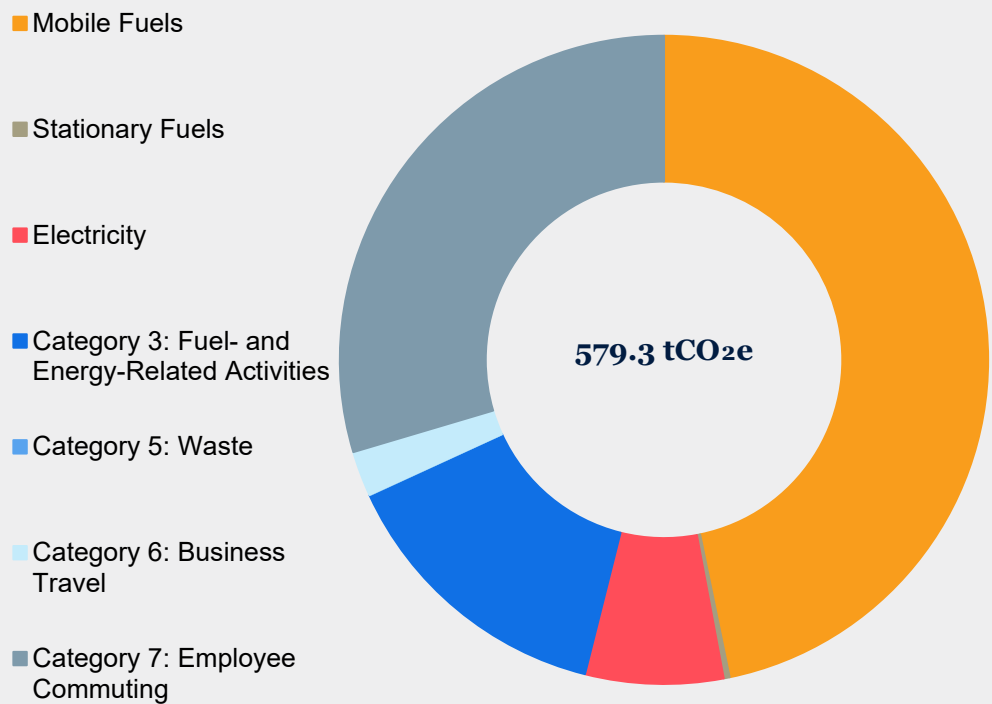

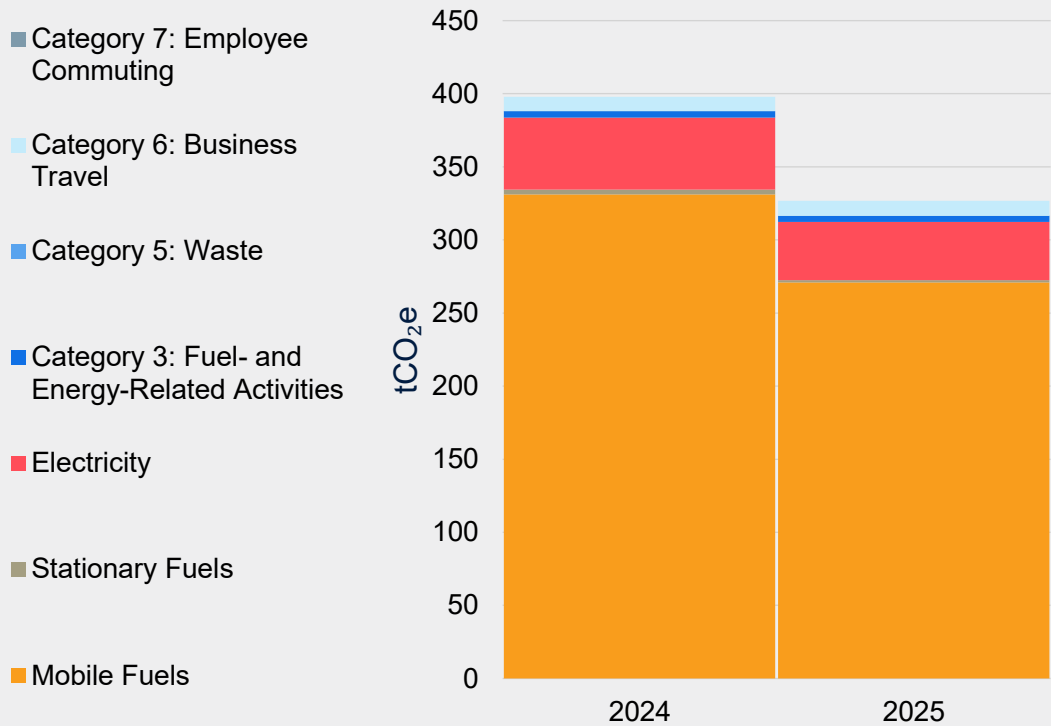
Measured carbon footprint and comparison by emission category
